A Resolution Supporting the Creation of a Campus-wide Provisional Land Acknowledgement, and to Respect the Legacy of Native Peoples.

WHEREAS, a land acknowledgment is a formal statement, often given orally at the beginning of organized events, celebrations, or activities, AND

WHEREAS, land acknowledgments serve to illuminate ongoing indigenous presence, as well as recognize and counter settler-colonial legacies of violence and land expropriation, AND

WHEREAS, the purpose of these statements is to show respect and honor the indigenous peoples that this land has been home to since time immemorial,¹ AND

WHEREAS, practicing acknowledgment can also raise awareness about histories that are often suppressed or forgotten,² AND

WHEREAS, to be consistent with the University's mission of diversity and inclusion, it is the responsibility of the University to disseminate knowledge of native peoples and their relation to the institution's history, **AND**

WHEREAS, through the institution of a land acknowledgement, many students would be exposed to the names of the traditional native inhabitants of the lands they are on, inspiring them to promote ongoing awareness and action,³ AND

WHEREAS, other national and Michigan peer universities like Michigan State University, University of Michigan, Western Michigan University, Central Michigan University, Kalamazoo College, Grand Valley State University, University of Cincinnati, and Michigan Tech University all have land or territorial acknowledgements to some extent,⁴ AND

WHEREAS, Wayne State University student organizations, faculty/staff affinity groups, academic units, and University personnel including the Wayne State Native American Student

NOW THEREFORE BE IT RESOLVED, that Wayne State University Student Senate calls upon the university to open public events and gatherings with the following acknowledgment:

Wayne State University rests on Waawiyaataanong, also referred to as Detroit, the ancestral and contemporary homeland of the Three Fires Confederacy. These sovereign lands were granted by the Ojibwe, Odawa, Potawatomi, and Wyandot nations, in 1807, through the Treaty of Detroit. Wayne State University affirms Indigenous sovereignty and honors all tribes with a connection to Detroit. With our Native neighbors, WSU can advance educational equity and promote a better future for the earth and all people, AND

NOW THEREFORE BE IT RESOLVED, that the Wayne State University Student Senate supports the creation of this provisional land acknowledgment, and for it to be sustained in perpetuity, **AND**

NOW THEREFORE BE IT RESOLVED, that the Wayne State University Student Senate calls upon the University to create a webpage on the University website in an accessible format for this land acknowledgement to be featured, and for such a webpage to be reachable from the homepage within three clicks or less, **AND**

NOW THEREFORE BE IT RESOLVED, that the Wayne State University Student Senate calls upon the University to financially support the development of an engraved plaque of the land acknowledgment to be placed at an approved campus location, **AND**

NOW THEREFORE BE IT RESOLVED, that the Wayne State University Student Senate calls upon the University to change the name of the Mad Anthony's convenience store because of Anthony Wayne's violent injustices toward tribal nations for which he earned that nickname.⁵

AND FINALLY BE IT ORDERED, that the Wayne State University Student Senate will circulate this resolution to all relevant outlets, including the University President, the University Provost, the members of the Board of Governors, the President of the Wayne State University Academic Senate, and The South End student newspaper.
