By-Law Amendment Rachel John, *Parliamentarian* Rabika Ali, Dhruval Bhatt, Finnley Culhane, *Parliamentary Committee*

A resolution to amend the Wayne State University Student Senate bylaws as presented.

THE WAYNE STATE UNIVERSITY STUDENT SENATE ENACT:

-----BY-LAW AS WRITTEN ARTICLE VI Section 2

MEETINGS POLICY

A. The Senate may go into closed session subject to the terms outlined below, at which point no one other than Senate members, alternates, and/or the advisor may be present.

i. Closed meetings

a. For elections, personal items, resolutions, or upon request

b. 2/3 of voting members (in attendance) must agree on this.

c. In the event of a vacancy election or other type of election, the option of a closed meeting must be announced. In this situation, the public must be excused from the room.

i. A closed interview or discussion will automatically go into effect at the (minimum) of one (1) request by a candidate or Senator, regardless of the other candidates' or Senators' preferences for the duration of the discussion. Candidates have the right to choose if their interview is public or private.

-----BY-LAW AS AMENDED-------

ARTICLE VI

Section 2

MEETINGS POLICY

A. The Senate may go into closed session subject to the terms outlined below, at which point no one other than Senate members, alternates, and/or the advisor may be present.

i. Closed meetings

- a. For elections, personal items, resolutions, or upon request
- b. 2/3 of voting members (in attendance) must agree on this.

c. Candidates have the right to choose if their interview is public or private. In the event of a vacancy election or other type of election, the option of a closed meeting must be communicated at least 24 hours prior to the election. The decision will then be made immediately before the election. In this situation, the public must be excused from the room.

i. A closed interview and discussion will automatically go into effect at the (minimum) of one (1) request by a candidate (including Senators running for the position), regardless of the other candidates' or Senators' preferences for the duration of the discussion. In this situation, the public must be excused from the room. Candidates have the right to choose if their interview is public or private.

-RATIONALE —

The WSU Student Senate recognizes that clarity and transparency should be the foundation of our bylaws. For this reason, we have amended **Article VI**, *Section 2* as follows:

- "In this situation, the public must be excused from the room"
 - \rightarrow This line was moved from section c to section c(i) as the latter's subject matter is more closely focused on closed interviews.
- "Including Senators running for the position"
 - → This line states that the wishes of those running in the election, including current senators, are the number #1 priority. Senators who are not running may not overrule the decision of those in the election.
- "Candidates have the right to choose if their interview is public or private"
 - \rightarrow This line was moved from section c(i) to section c as the latter's subject matter is more closely focused on interviews as a whole.
- "Communicated 24 hours prior", "immediately before the elections"
 - This line explicitly states the recurring role of the President in this process to ensure candidates are aware of the choices they are entitled to.
- "Interview and discussion"
 - This new phrasing clarifies that if the interview is closed, then the discussion must be closed.
